

The IKEA Way of Responsibly Procuring Products, Services, Materials and Components (IWAY Standard)
Compliance Commitment (ICC)

1. General Requirements

- 1.1 *Supplier* undertakes to at all times comply with all relevant local, national and international laws, regulations and provisions applicable in the country of production and/or country where services are provided, and any additional requirement stated in IWAY Standard as defined below which may impose more strict requirements than such laws, conventions, regulations and provisions.

2. Fulfilment of IWAY Standard Requirements

- 2.1 In addition to the general requirements stated in section 1 above, *Supplier* undertakes to implement and at all times fulfil all IWAY MUST requirements from start of first delivery or service and IWAY BASIC requirements within 12 months of first delivery or service as defined in IWAY Standard (IWAY Standard here means the General Section, additional Sections and Ingka Group IWAY Specifications, all incorporated herein by reference). *Supplier* undertakes to implement all successive modifications and integrations of IWAY Standard.

3. Ingka right to inspect and review

- 3.1 *Supplier* must secure Ingka's rights to IWAY review of all tiers of *sub-contractors* in scope as specified in the IWAY Standard. Ingka and/or by Ingka appointed third party auditing organization is entitled to perform announced and unannounced reviews and inspections at *Supplier's* and/or *sub-contractors'* facilities and/or locations where the product is manufactured or the service is provided. *Supplier* and/or *sub-contractors* shall allow for confidential interviews with their employees and shall maintain and allow access to all IWAY related documentation and records as required. *Supplier* and/or *sub-contractors* shall in good faith support IWAY reviews to the extent required to confirm compliance to IWAY Standard as defined in 2.1 above.
- 3.2 If *Supplier* and/or *sub-contractors* does not fulfill the requirements in IWAY Standard, this will constitute a material breach of any contract and agreement with Ingka Group, and Ingka Group may at its sole discretion and without any compensation to *Supplier*, immediately terminate all existing agreements with *Supplier*, and cancel any existing orders.

Our experience working with IWAY has shown us that when people, the planet and animals are treated with respect, *workers* are more productive, resources are utilised more efficiently, and business thrives. Our customers benefit too – knowing that all goods IKEA sells are produced, transported, delivered and assembled responsibly and that *suppliers* of our stores, customer touchpoints and production sites maintain good social, environmental and animal welfare conditions.

When working with IWAY, we are continually guided by the following questions:

By committing to meet IWAY, you are expected to secure the following:

Responsibility

You are responsible to comply at all times with local, national and international laws, as well as with all IWAY Must and IWAY Basic requirements defined in the IWAY Standard.

Openness

You are open and honest about areas that require improvement.

Continual improvement

We recognise the time and effort required to implement the IWAY Standard and encourage you to adopt a continual improvement mind-set, to strengthen performance and go beyond the IWAY Basic requirements, as required.



We recognise that our actions make a difference too

We strive to take a fair and open approach to how we work with you. This means that:

Alignment

We aim to live up to the same expectations internally as we require of you.

Dialogue

We maintain open lines of communication with all our *suppliers* and welcome any feedback you may have on our performance and behaviour.

Support

Where possible, we provide you with practical support to help you develop your own processes, adapted to your operations, to enable you to meet and continuously improve, in line with the IWAY Standard.



The IWAY principles and requirements are based on internationally recognised standards and principles

These reflect our commitment to the UN Guiding Principles on Business and Human Rights (UNGPs) and are based on the Ten Principles of the UN Global Compact. In developing our requirements, we have also been guided by the UN Sustainable Development Goals (SDGs) and the ILO Centenary Declaration for the Future of Work, among others.

IWAY is structured according to:

Principles

The principles define the IKEA standpoint on responsibly procuring products, services, materials and components.

Sections

The sections group IWAY requirements and are applicable depending on the activities or setups of *suppliers*.

THE IWAY REQUIREMENTS

MUST

Requirements that must be met at all times when doing business.

BASIC

Requirements that must be met within 12 months of first delivery or service.

ADVANCED

Requirements that go beyond minimum compliance and define additional steps towards more sustainable practices. These may or may not be applicable depending on the priorities set by the relevant IKEA organisation.

EXCELLENT

Requirements that go beyond minimum compliance and define additional steps towards more sustainable practices. These may or may not be applicable depending on the priorities set by the relevant IKEA organisation.

The most demanding requirements are always complied with, whether they are legal or IWAY requirements. Should IWAY requirements contradict the applicable laws or regulations, the law is complied with and prevails. In such cases, IKEA is informed immediately and alternative ways to respect the IWAY requirement are looked for.

We encourage attempts to drive harmonisation of requirements and ways of working

IKEA recognises that *suppliers* may have their own Code of Conduct, work with another buyer's Code of Conduct or be certified according to a sustainability scheme that is comparable to IWAY. IKEA supports alternative approaches to implementing IWAY requirements. IKEA reserves the right to decide whether such approaches are equivalent.

Successful implementation of IWAY depends on cooperation, mutual trust and respect

All observations, discussions and information received from you are treated confidentially by IKEA, its co-workers and any third party organisations appointed by IKEA. Any data gathered in relation to IWAY is treated respectfully and for the sole purpose of verifying compliance to IWAY.

The official language of the IWAY Standard is English

Translations of the IWAY Standard are provided for information purposes only, and cannot be relied upon as contractual documentation. The English version is the sole contractual document and prevails in case of ambiguities or discrepancies.

Requirements for all suppliers



1 IWAY principles are supported by effective *routines* and open dialogue

PERFORMANCE MANAGEMENT



- G 1.1 Accountability and responsibility related to IWAY has been granted to one or more management-level representatives.
- G 1.2 Internal audits to assess compliance with IWAY requirements are conducted at least once every 12 months.



- G 1.3 Written policies and *routines* covering IWAY are in place.
- G 1.4 Indicators and plans are in place to measure and improve performance related to IWAY.

SUPPLY CHAIN MANAGEMENT



- G 1.5 *Sub-contractors* of products, services, materials or components in the IKEA *value chain* are mapped, in line with IKEA organisation specifications.
- G 1.6 IWAY is implemented and verified at *sub-contractors* of products, services, materials or components in the IKEA *value chain*, in line with IKEA organisation specifications.



- G 1.7 Social and environmental risks in the IKEA *value chain* are identified and actions are taken to mitigate them.

WORKER/MANAGEMENT DIALOGUE

BASIC

- G 1.8 Workers are informed of their rights and responsibilities related to IWAY.
- G 1.9 There is a structured dialogue with *workers* related to IWAY.



2 Business is conducted lawfully and with integrity

BUSINESS ETHICS

MUST

- G 2.1 Trust and transparency related to the IKEA business are ensured. Attempts to break the law, falsify documents, deceive, or commit corruption are not accepted.

BASIC

- G 2.2 All applicable laws, regulations and permits related to IWAY are complied with.

3 *Children are protected and opportunities for work, learning and family life are promoted*

PROTECTION OF CHILDREN

MUST

- G 3.1 There is no *child labour*. Any potential or confirmed case of *child labour* is immediately reported to IKEA.

BASIC

- G 3.2 *Children* do not perform work below the *minimum legal working age*. *Vocational trainees* may participate in training from 14 years of age. Training is related to their education.
- G 3.3 *Children*, whether as *young workers* or *vocational trainees*, do not perform *hazardous work* or night work.

OPPORTUNITIES FOR WORK AND LEARNING

BASIC

- G 3.4 Work opportunities for *young workers* are identified and promoted.

ADVANCED

- G 3.5 *Vocational training* opportunities for *children* are identified and promoted.

OPPORTUNITIES FOR FAMILY LIFE

ADVANCED

- G 3.6** *Workers receive childcare support in addition to that defined by applicable legislation.*



4 *Fundamental labour rights are respected*

WORKER FREEDOM

MUST

- G 4.1 There is no *forced, bonded or prison labour*. Any potential or confirmed case of *forced, bonded or prison labour* is immediately reported to IKEA.

BASIC

- G 4.2 Overtime hours are voluntary and *workers* refusing overtime hours are not penalised. Under certain circumstances well defined by applicable legislation, overtime hours may be mandatory for a short period if agreed through *worker* representation, where applicable.

FREEDOM OF ASSOCIATION AND GRIEVANCES

BASIC

- G 4.3 *Workers* are free to exercise their right to form or participate (or not) in work-related organisations, as well as engage in *collective bargaining*. These rights are exercised without fear of *discrimination*, violence or harassment, whether physical or psychological.
- G 4.4 A grievance mechanism is in place and known to *workers*, enabling them to raise complaints or concerns without retaliation. Complaints are recorded and acted upon and the anonymity of *workers* is protected.

WORKING HOURS AND TIME OFF WORK

- G 5.1 A reliable system for registering *working hours*, including overtime, of all *workers* is maintained.

BASIC

- G 5.2 *Working hours* do not exceed 60 hours per week, including overtime.
- G 5.3 *Workers* have at least one break of 30 minutes after every 4.5 hours worked, unless otherwise agreed in writing through *worker* representation.
- G 5.4 *Workers* have at least 24 consecutive hours of rest after 6 days of work.

ADVANCED

- G 5.5 *Workers* have the opportunity to take time off from work for exceptional personal circumstances, in addition to that defined by applicable legislation.
- G 5.6 Regular *working hours* do not exceed 48 hours per week. Overtime *working hours* do not exceed 12 hours per week.

EXCELLENT

- G 5.7 Work is planned in such a way that it does not rely on overtime.

6 Workers' health and safety are protected

OCCUPATIONAL HEALTH AND SAFETY MANAGEMENT

- G 6.1** *Workers* are not exposed to *severe occupational health and safety hazards*. Fatalities are immediately reported to IKEA.
- G 6.2** *Accident* insurance is provided to all *workers*. Insurance covers medical treatment for work related injuries and illnesses and provides compensation for work related injuries and illnesses resulting in permanent disability or death.

BASIC

- G 6.3** Occupational health and safety risks, including those related to mental health and ergonomics, are assessed and actions are taken to mitigate them.
- G 6.4** Safe working *routines* are implemented to minimise the risks associated with *hazardous work*.
- G 6.5** Equipment is safe and used under safe conditions. Warning signs and safety information are visible.
- G 6.6** *Workers* use personal protective equipment and protective clothing that are clean, free of charge, in working order and appropriate for the risks identified.
- G 6.7** *Accidents* and *near misses* related to occupational health and safety are reported, analysed, followed-up and acted upon. Records of *accidents* and *near misses* are kept.
- G 6.8** Safety *hazards* are continuously reported, analysed, followed-up and acted upon.

7 Working and living conditions are suitable

WORKING CONDITIONS

BASIC

- G 7.1 The working environment is clean, hygienic and well maintained and has adequate light, ventilation and, when necessary, heating.
- G 7.2 Places where *workers* can eat and rest are available, are away from any *hazards* and are proportional to the number of *workers*.
- G 7.3 Toilets are free of charge, hygienic, accessible during *working hours*, equipped with basic supplies and proportional to the number of *workers*.
- G 7.4 Unlimited, clean drinking water is available free of charge and within a reasonable distance of the work area.

8 The planet is protected

ENVIRONMENTAL IMPACTS

MUST

- G 8.1 There is no *severe environmental pollution*. Any case of *severe environmental pollution* is immediately reported to IKEA.

BASIC

- G 8.2 Environmental complaints are recorded and acted upon.
- G 8.3 The risk of ground contamination due to current or previous activities is assessed and acted upon.
- G 8.4 Environmental risks and impacts are identified and assessed in order to find ways to improve environmental performance. Environmental improvement plans are implemented, reviewed and updated every 12 months.

ADVANCED

- G 8.5 Environmental impacts are assessed when evaluating operational and structural changes.

AIR POLLUTION AND CLIMATE

BASIC

- G 8.6 Current energy sources are known and possibilities to convert to *renewable energy* sources are identified.

ADVANCED

- G 8.7 All consumed electricity, generated or purchased, comes from *renewable energy* sources.
- G 8.8 No *ozone depleting substances* or *hydrofluorocarbons* are used.
- G 8.9 No fossil coal- or oil-based fuels are used on site as a primary source of energy.

EXCELLENT

- G 8.10 Emissions of air pollutants and *greenhouse gases* are reduced in absolute terms, in line with limiting the global temperature increase to well below 2°C, aiming towards 1.5°C, by the end of the century (as set in the *Paris Agreement*).
- G 8.11 All consumed energy, generated or purchased, comes from *renewable energy* sources.

CONSERVATION AND BIODIVERSITY

BASIC

- G 8.12 Business activities are not conducted in *High Conservation Value Areas*, unless the area is certified according to a system recognised by IKEA.

ADVANCED

- G 8.13 Initiatives to support biodiversity are implemented.

Glossary

| <i>Children</i> | Persons under the age of 18 years, unless, under the law applicable to the <i>child</i> , majority is attained earlier. |
| <i>Child labour</i> | Work performed by <i>children</i> under the <i>minimum legal working age</i> that deprives them of their childhood, potential and dignity and that is harmful to their physical and mental development. Furthermore, work done by any person under 18 years of age can also be considered “ <i>child labour</i> ”, depending on the type and hours of work performed and the conditions under which it is performed. |
| <i>Collective bargaining</i> | Negotiations between the employer and <i>worker</i> representatives, freely and independently chosen by <i>workers</i> . |
| <i>Discrimination</i> | <p><i>Discrimination</i> occurs when a person is treated less favourably than another in a comparable situation on grounds that are not related to their capability to do the job.</p> <p>Grounds for <i>discrimination</i> include: age, gender identity, sexual orientation, mental or physical disability, ethnicity, nationality, religion, marital or family status or any other dimension of a person's identity that bears no relation to their capability to perform the job.</p> |
| <i>Dismissal</i> | The situation in which an employer officially makes someone leave their job for any reason, unless as a result of a disciplinary process agreed with or not contested by the <i>worker</i> or confirmed by the authorities. This includes cases where <i>workers</i> are laid off or made redundant. |

Diversity

Diversity refers to the variety of similarities and differences among people, including age, gender identity, sexual orientation, mental or physical disability, ethnicity, nationality, religion, marital or family status or any other dimension of their identity.

Emergency exit

An *emergency exit* is illuminated or indicated with a photo luminescent sign. The exit opens outwards, is kept unlocked and is unblocked at all times.

Emergency response team

Team of *workers* with appropriate competence to coordinate the emergency response: evaluation of the emergency, immediate decision-making, support to local authorities and emergency services, and external and internal communication.

Emergency route

Route leading towards an *emergency exit*. The route is kept unblocked at all times.

Equality

Equality means that everyone shall be treated fairly and provided with equal opportunities, regardless of their background and their individual differences. *Equality* also implies the absence of any kind of *discrimination*.

Forced, bonded or prison labour

Forced labour is any work or service that is performed by any person under the menace or threat of a penalty, and which the person has not entered into of his or her own free will. This includes the confiscation of personal belongings, the inability to terminate employment at any time and the inability to leave work premises.

Bonded labour is a form of *forced labour* in which *workers* are bound to their job through debt bondage, as a result of being charged, directly or indirectly, recruitment fees or costs, paying deposits, receiving loans or wage advances or having payments delayed.

Prison labour is work conducted by prisoners.

Fundamental labour rights

For the purpose of IWAY, *fundamental labour rights* include freedom from *forced and bonded labour*, *non-discrimination*, freedom of association and the right to *collective bargaining*.

- A 7.8 *Accommodation* is not located in a building where high-risk operations take place. *Accommodation* is located away from loud sources of noise.

ADDENDUM TO THE TERMS AND CONDITIONS OF THE IWAY STANDARD

1. Glossary

- 1.1 The parties hereby agree that the '*Worker*' definition in Glossaries of General Section and applicable Additional Sections is replaced in its entirety with the following:

"A person performing work full-time or part-time. This includes piece rate *workers*, vocational trainees and *workers* undergoing a probationary period, as well as *sub-contractor workers*."

2. Ingka Group IWAY Specifications for General Section

- 2.1 The parties have agreed to the changes and/or additions to IWAY Standard, General Section, as set forth herein. These Ingka Group IWAY Specifications are the 'IKEA organisation specifications' for Ingka Group referred to in IWAY Standard, General Section.

- 2.2 The parties hereby agree that requirement G 1.5 in Principle 1, Supply Chain Management, in General Section is replaced in its entirety with the following:

"G 1.5 (i) *Sub-contractors* of products, services, materials or components in the IKEA *value chain* are mapped, in line with IKEA organisation specifications.

G 1.5 (ii) The *sub-contractor* mapping should be done for all *sub-contractors* falling under the *sub-contractor* scope in requirement G 1.6 (ii) below. The mapping must always be kept updated by the *supplier* and should be given to Ingka upon request."

- 2.3 The parties hereby agree that requirement G 1.6 in Principle 1, Supply Chain Management, in General Section is replaced in its entirety with the following:

"G 1.6 (i) IWAY is implemented and verified at *sub-contractors* of products, services, materials or components in the IKEA *value chain*, in line with IKEA organisation specifications.

G 1.6 (ii) For fulfilling requirements under G 1.5 and G 1.6, *supplier* must secure the requirements G 1.5 and G 1.6 in the agreement with *sub-contractors* for all tiers in the *value chain*. In relation to G 1.5 and G 1.6, *sub-contractors* shall be defined as a company:

- a) Performing processes, and services, that are considered to be potentially highly harmful to the environment, health or safety of the *Workers* or are in an industry or supply setup that is prone to *child labour* or *forced, bonded or prison labour* (as defined by the IWAY Standard), or posing risks as identified during the Initial Assessment; and/or
- b) Providing services that connect with the IKEA customer; and/or
- c) Providing products or services, including transport, that are identifiable with the IKEA brand or are IKEA branded; and/or
- d) Providing services on IKEA premises; and/or
- e) Producer of a semi-finished product used in a final product for IKEA.

G 1.6 (iii) The minimum scope for IWAY implementation and verification for *sub-contractors* are the IWAY MUST requirements. However, in the case that *sub-contractors* are providing the entire service, as described in the contract, then the minimum scope are IWAY MUST and IWAY BASIC requirements.”

3. IWAY Process

- 3.1 Ingka Group periodically reviews the application of the IWAY Standard by its *suppliers* with on site or remote reviews carried out by Ingka Group professional reviewers or 3rd party professional auditors authorised by IKEA.
- 3.2 The periodicity of the reviews is determined by a risk assessment of the *suppliers* carried out on objective data. The same *supplier* can receive for example three reviews in one year and then one review every four years, depending on its risk. The *suppliers'* risk level is an internal Ingka Group information, it can change over the time and is not communicated.
- 3.3 During the reviews, the reviewer has access to *workers* data, can see all the areas of the *supplier's* units and has access to administrative information, in relation to IWAY. The reviewers confidentially interview in private the *workers* with questions related to IWAY requirements. All information is treated with the maximum of confidentiality and no copies of document are brought away. During the reviews, the reviewer can also review the *sub-contractors*. The reviewer can take pictures, with the approval of the *supplier*.
- 3.4 Generally, the reviews are announced, meaning that the date and the scope is agreed with the *supplier* few weeks in advance. There are cases when the review is unannounced, carried out therefore without any previous communication.
- 3.5 The review report is shared with the supplier few days after the review. The *supplier* is required to prepare a corrective action plan for all the noncompliance's, addressing the root causes for avoiding their repetition. The reviewer approves the corrective action plan and then assess (with a site visit or remotely) the its effective application in the given time frame.
- 3.6 Noncompliance's not resolved within the deadlines lead to business consequences: stop of orders, non-renewal of the contract, suspension or immediate termination of the contract.
- 3.7 IWAY MUST requirements are the most important requirements of the IWAY Standard. Noncompliance's to those requirements require an immediate reaction and an immediate elimination of the causes, otherwise immediate business consequences are applied, including termination of the contract.

4. Miscellaneous

- 4.1 The word and expressions defined in this Addendum shall, unless otherwise defined herein, have the same meaning as in the IWAY Standard.
- 4.2 The IWAY Standard shall remain in full force and effect except as expressly changed and amended hereby.

- 4.3 This Addendum shall be considered an integrated part of the IWAY Standard and shall only be read, interpreted and used as such.
- 4.4 In case of any conflict between this Addendum and IWAY Standard, the terms of this Addendum shall prevail.
- 4.5 ICC, IWAY Standard and Ingka Group IWAY Specifications for General Section are periodically updated and improved. The *supplier* accepts all the future amendments of the ICC, IWAY Standard and Ingka Group IWAY Specifications for General Section communicated by Ingka Group.

**Construction Amendment of The IKEA Way of Responsibly Procuring Products, Services,
Materials and Components (IWAY Standard) Compliance Commitment (ICC)**

1. Background

1.1 The parties have agreed to the changes and/or additions to ICC as set forth herein.

2. Amendments

2.1 The parties hereby agree that section 2.1, Fulfilment of IWAY Standard Requirements, in ICC (in IWAY Appendix) is replaced in its entirety with the following:

“2.1 (i) The following requirements are applicable for all *Suppliers* and all tiers *sub-contractors* associated with the construction service and operating on site.

2.1 (ii) In addition to the general requirements stated in section 1 above, *Supplier* undertakes to implement and at all times fulfil all IWAY MUST requirements as defined in IWAY Standard (composed of the General Section, additional Sections, e.g. Accommodation Section, if applicable, and Ingka Group IWAY Specifications, all incorporated herein by reference), and all IWAY BASIC requirements as defined in IWAY Standard in General Section, Principle 6, Workers' health and safety are protected and all IWAY BASIC requirements as defined in IWAY Standard Accommodation Section, if applicable, from start of first delivery or services.

2.1 (iii) In addition, for services (e.g. projects) exceeding six (6) months, *Supplier* also undertakes to implement and at all times fulfil all IWAY BASIC requirements as defined in IWAY Standard after six (6) months from first delivery or services.

2.1 (iv) If the additional Accommodation Section applies, *Supplier* undertakes to implement and at all times fulfil all IWAY BASIC requirements in IWAY Standard (composed of the General Section and applicable additional Sections) from start of first delivery or services.

2.1 (v) *Supplier* undertakes to implement all successive modifications and integrations of IWAY Standard.

2.1 (vi) Overview of applicable IWAY requirements for construction services (e.g. projects):

3.1 (i) For services below six (6) months, *Supplier* is responsible to secure Ingka's rights to IWAY review of all tiers of sub-contractors associated with the construction service and operating on site".

4 Miscellaneous

4.1 The word and expressions defined in this Construction Amendment of ICC shall, unless otherwise defined herein, have the same meaning as in the IWAY Appendix.

4.2 The IWAY Appendix shall remain in full force and effect except as expressly changed and amended hereby.

4.3 This Construction Amendment of ICC shall be considered an integrated part of the IWAY Appendix and shall only be read, interpreted and used as such.

4.4 In case of any conflict between this Construction Amendment of ICC and IWAY Standard the terms of this Construction Amendment of ICC shall prevail.
